

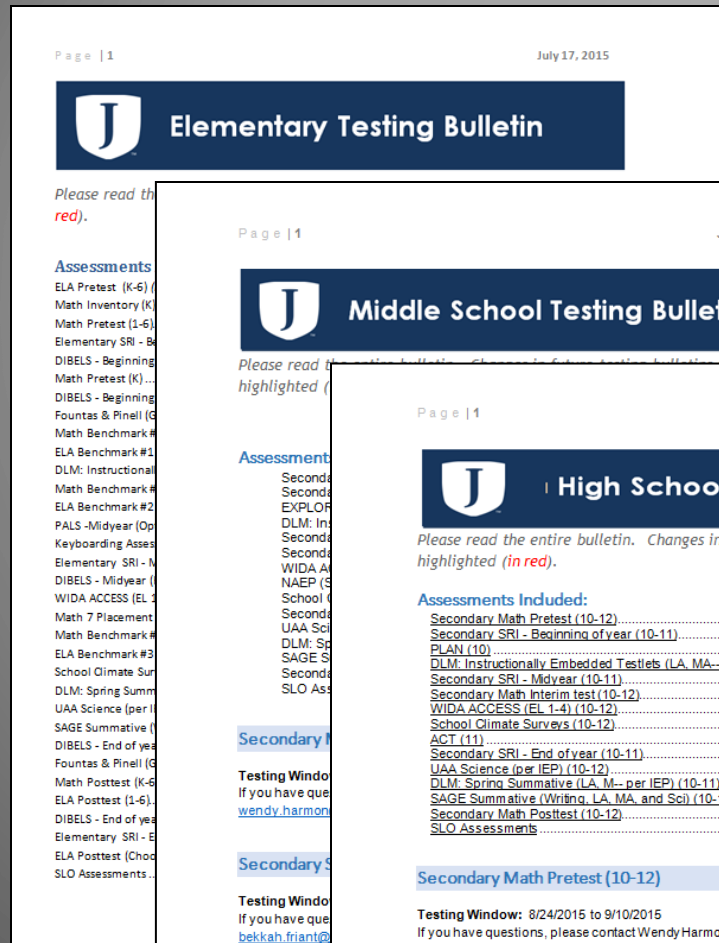

For SLO assessments, the pretest and posttest windows may include days students are not in school in order to allow teachers time to prepare these assessments for administration to students.

Subsequent monthly testing bulletins will include only current and future specific assessments.

SLO Assessment information will be retained in all monthly bulletins.



Each specific assessment listed identifies grades that are to participate in the assessment, the assessment's testing window, any specific notes pertaining to the assessment, and contact information for individuals who can answer questions about the assessment.

Secondary SLO Assessments include testing windows for quarter, semester, and full-year courses.

Brooke Anderson will be maintaining, updating, and distributing the monthly testing bulletins. Her contact information is provided at the end of the bulletin.

Items Pertaining to Specific Assessments for 2015–16...

▶ ALL LEVELS:

- *DLM* – (LA and MA) will be administered twice during the school year.
- *School Climate Surveys* – Because of its role in educator evaluations, please plan to encourage increased student, teacher, and especially parent participation within this four-week survey window.
- *SAGE* – Writing, LA, MA, and SC will all be tested during the same window. There will not be a separate window for writing. The testing window will be 8 weeks long.
- *SLO Pretests and Posttests* –
 - It is important that ALL teachers complete SLO pre and post assessments within the prescribed testing windows.
 - Be mindful of the different pretest and posttest windows for quarter, semester, and full-year courses.

▶ Elementary:

- Schools will be piloting ELA or participating in PALS for K.
- DIBELS will be administered to K as well as 1–3.
- Math benchmark assessments #1, #2, and #3 provide the assessment due date as opposed to a testing window.
- SRI participation is optional for elementary schools. (Mid-year SRI required for 6th grade)
- *SAGE – YR Schools...* when scheduling SAGE tests, be mindful of Track A which has the largest number of “off-track” days during USOE’s designated SAGE testing window.

▶ Middle

- This will be the last school year for administering the EXPLORE® test.

▶ High

- This will be the last school year for administering the PLAN® test.

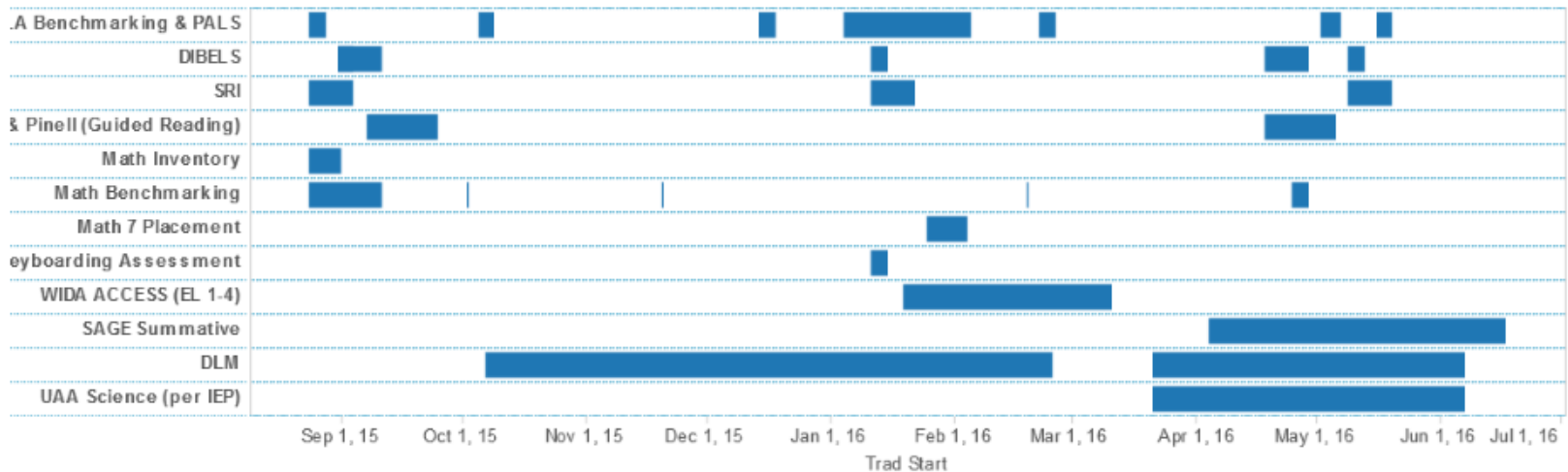

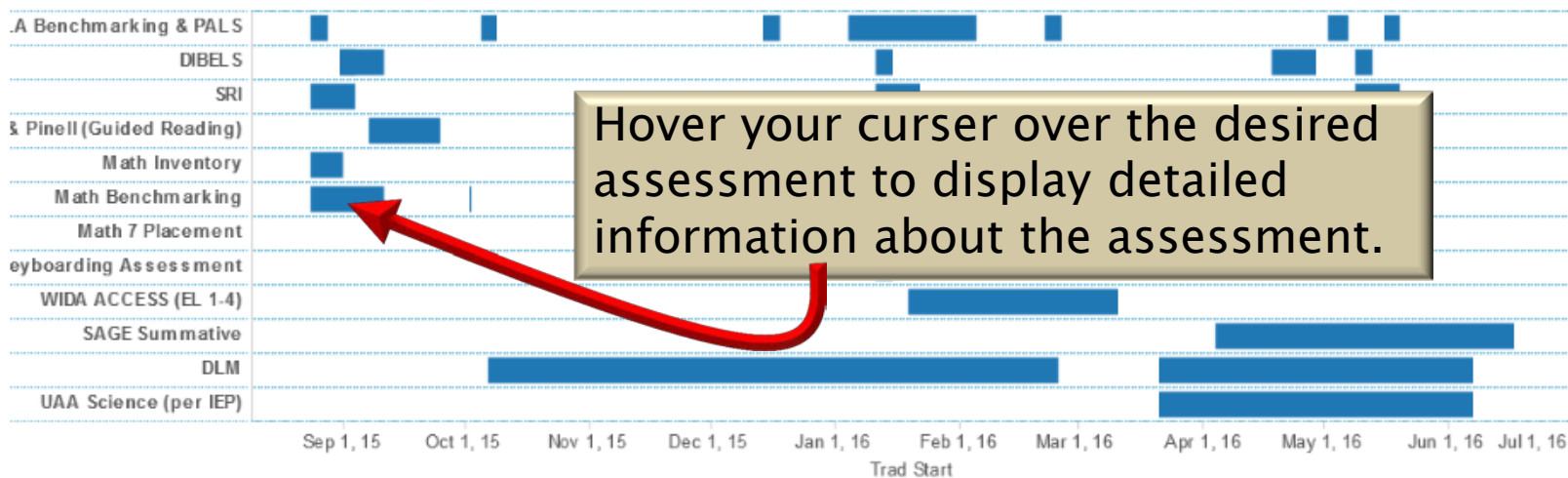


